Management Discussion of Fund Performance Investment Objectives and Strategies

The investment objective of the Kingwest U.S. Equity Portfolio (the "Fund") is to provide capital appreciation through investments in equity securities listed on recognized U.S. stock exchanges. The Fund focuses on companies that will increase in value for reasons not related to the general movement in stock prices but related to some development in the company's affairs not reflected in its share price.

Risk

This Fund is suitable for investors seeking long-term above-average growth who can tolerate average volatility. Although the Manager does take measures to mitigate and manage risk, this Fund should be considered a medium-risk fund due to its focus on equities. General risks of investing in the Fund remain as discussed in the Prospectus. The major risks for the Fund are stock market risk, specific issuer risk, liquidity risk, and currency risk. The Manager attempts to reduce exposure to these risks by diversifying among 25-30 companies.

Currency Risk

The Fund is valued in Canadian dollars; however, it invests primarily in U.S. securities denominated in U.S. Dollars. In order to reduce the impact of short-term currency fluctuations, we may employ currency hedging. Specifically, we may hedge all or a portion of our foreign currency exposure depending on our view of a currency's relative value and its associated risks. As at December 31, 2024, the Fund's most significant foreign currency exposure was to the U.S. dollar, which as a gross percentage of total net assets was approximately 100%. 22.5% of the Fund's exposure to the U.S. dollar was hedged at the end of 2024

Results of Operations

Investment Performance

For the year ended December 31, 2024, Kingwest U.S. Portfolio, Series F, increased by 36.6% versus an increase of 36.4% for its benchmark, the S&P 500 Index (total returns in C\$).

We manage the Fund independently of the indexes we use as long-term performance comparisons. Differences including security holdings and geographic/sector allocations may impact comparability and could result in periods when our performance differs materially from the index.

During the period, the Fund's outperformance relative to the index can mainly be attributed to the Fund's allocation to Communication Services and Financial sectors. Security Selection, rather than Asset Allocation, within these sectors was a major contributor to the Fund's outperformance.

Please refer to the Past performance section for the performance of other series, which differs from Series F due largely to varying expenses and/or taxes incurred by each series, as explained in the Prospectus.

On a sector basis, the Fund's Communication Services and Financials holdings were the largest contributors to overall performance. The Fund's holdings in Information Technology and Consumer Discretionary were the major sector detractors to investment results in 2024.

Meaningful contributors to investment results included:

As a group, these companies contributed approximately 26.2% to overall performance in the last 12 months.

Significant detractors to investment results included:

- Skyworks Solutions Inc
- Sonos Inc
- Comcast Corp

As a group, these companies contributed approximately a negative 0.7% to overall performance in the last 12 months.

While we provide these results to fulfil the disclosure requirements of this report, we measure investment success over periods of 5 years or more and believe it takes considerable skill to consistently add value over the long term.

Portfolio Transactions

Businesses Purchased

During the period, businesses added to the Fund include:

- <u>Apollo Global Management</u> Alternative asset management company
- <u>Lazard</u> Financial advisory and asset management service provider

Businesses Sold

We generally sell a stake in a business for one of three reasons. First, if our outlook for the business changes. Second, if the potential forward appreciation is lower. Third, an alternative business of higher quality or more attractive forward return is available.

During the period, businesses sold include:

Portfolio Composition

Sector Exposure

Overall sector exposure shifted primarily as a result of investment decisions and changes in stock prices. The most significant change was an increase of 7.6% in the Fund's Financials holdings, primarily due to market appreciation of the securities within the Financials Sector and the addition of Apollo Global Management and Lazard Inc. The Fund's Industrials holdings decreased by approximately 5.2%, primarily due to the sale of Trane Technologies. The Fund's cash position was 7.9% at the end of 2024, compared to 9.0% at the end of 2023.

Portfolio transactions are a result of our "bottom-up" stock selection process. We don't construct the Fund with an index or benchmark in mind. As a result, the Fund's composition is typically very different from its benchmark index. Our approach to portfolio construction focuses on the quality of the constituent businesses and minimizing the possibility of permanent loss of capital. Although we keep macro-level market issues in mind, they aren't a primary driver in our investment process.

Recent Developments

Continuing conflict in Ukraine, war in the Middle East and the U.S. election were major geopolitical issues in 2024.

For the year, the S&P 500 Total Return Index increased 36.4% (C\$; Source: Bloomberg).

During 2024, the Information Technology and Financials sectors within the S&P 500 Index accounted for more than 54% of the index's total return. The largest individual security contributor was Nvidia Corp, which accounted for about 17% of the index return.

Our House Style focuses on quality businesses with internal developments that will drive their business forward independent of the broader market. We only acquire and hold these companies while their stock prices trade below our appraisal value. Given our owner's approach mindset, the Fund's portfolio looks

very different from its benchmark index, the S&P 500 Index.

During the year, we purchased 2 new businesses and sold our position in 3 businesses.

Related Parties Transactions

Manager

Brokerage fees in the form of commissions incurred to Kingwest in connection with arm's length purchase and sale of securities of the Portfolio during the year amounted to \$53,226 (\$13,432 in 2023). These fees are measured at the exchange amount and are in the normal course of business.

As at December 31, 2024, the principals of the Manager and parties related to the principals own 118 redeemable units of Kingwest U.S. Equity Portfolio Series F (0 units in December 31, 2023); 98,395 redeemable units of Kingwest U.S. Equity Portfolio Series O (91,141 units in December 31, 2023); and 181 units of Kingwest U.S. Equity Portfolio Series O in CAD (0 units in December 31, 2023).

Independent Review Committee (IRC)

Kingwest has appointed an IRC consisting of three independent members and established under the Canadian Securities Administrators' National Instrument 81-107. The IRC's mandate is to review and provide input on Kingwest's written policies and procedures that pertain to conflict of interest matters with respect to Kingwest-managed funds, including Kingwest affiliates. The Fund has not relied on the positive recommendation or approval of the IRC to proceed with any transaction.

Management Fees

As compensation for the services provided, Kingwest, the Manager of the Fund, receives an internal management fee of 80 basis points on daily net asset value for the Series F.



Benchmark

The Fund uses the S&P 500 TR (CAD) Index as its benchmark for long-term performance comparisons. While the Fund uses this index for long-term performance comparisons, it is not managed relative to the composition of the index. There are differences which include security holdings, geographic and sector allocation which impact comparability. As a result, the Fund may experience periods when its performance differs materially from the index.
