# Reliq Health Technologies, Inc. Announces Transfer to NEX

HAMILTON, ON, August 19, 2024 / - Reliq Health Technologies Inc. (TSXV:RHT or OTC:RQHTF or WKN:A2AJTB) ("Reliq" or the "Company"), a growing global healthcare technology company that develops innovative Virtual Care solutions for the multi-billion dollar Healthcare market, announces its listing on NEX, a separate board of the TSX Venture Exchange (the "TSX-V"). As the Company is currently subject to a Failure-to-File Cease Trade Order ("FFCTO") issued by the British Columbia Securities Commission ("BCSC") for failure to satisfy financial reporting requirements (as previously disclosed on January 25, 2024), the Company will be transferred to NEX.

The Company will move from the TSX-V to the NEX at market open on Tuesday, August 20, 2024. Upon the transfer of its listing to NEX, the trading symbol of the Company's common shares will change from "RHT" to "RHT.H". There is no change in the Company's name, CUSIP number, or ISIN number.

Trading in the shares of the Company will remain suspended until the Company comes back into good standing with the securities commissions and with its continuous disclosure obligations, at which time the Company can apply for a reactivation of its listing on TSX-V. The Company continues to work towards completing its financial reporting requirements and an update will be provided via a news release in due course. The Company also confirms, as of the date of this news release, that there is no other material information concerning the affairs of the Company that has not been generally disclosed.
